BETWEEN

1. **SCS Rescotiou**, 2 rue Jacques Daguerre, F-92 565 Rueil Malmaison Cedex, France
(hereinafter with its successors called "**Employer**")

AND

2. **ENERCON GmbH** of Dreekamp 5, D-26605 Aurich, Germany (hereinafter with its successors and permitted assigns called "**Contractor**")

RECITALS

- A. The Employer desires the execution of certain works known as a windfarm built in Rescotiou I, city of Kergrist Moelou, Côtes d'Armor department, France
- B. The Contractor has offered to execute the aforementioned works, namely to design, deliver, construct and commission 6 (six) Wind Turbine Generators, type E-82, windclass II, hub height 98 m and 2,0 MW.
- C. The Employer accepts the Contractor's offer, and it agrees that in consideration for the execution of the works by the Contractor, the Employer shall pay the Contractor in accordance with the Contract. The Contract becomes effective once each party has signed and delivered it to the other party.

Now, in consideration of the terms set out hereunder, the parties convene and agree as follows:

BASIS OF CONTRACT

The Contract between Employer and Contractor is evidenced by this document and the documents as enumerated below. Should there be any discrepancy or inconsistency between the documents which constitute the Contract the following order of priority shall apply:

- a) This Contract Agreement;
- b) The Appendix;
- c) The General Conditions of Contract;
- d) The Annexes 1 - 10;
- e) SNET general purchase conditions
- f) Any laws, by-laws, regulations and directives as applicable to the Contract.
